DECLARATION and DISCLAIMER

This Agent Agreement (AA) is designed to clarify what is reasonably expected of Agents, confirm the commitment of the Agent to comply with this AA and to specify the consequences, in the unlikely event that the Agent fails to comply with this AA.

The Agent hereby agrees,

1. The Agent declares that:
 - i. the information given in this Agent Application is complete and correct to the best of the Agent's knowledge;
 - ii. the Agent has read and fully accepts all CHI Invoice Terms and Conditions;
 - iii. the Agent agrees that their Students are expected to pay for any and all expenses incurred by the Student or on the Student's behalf at the homestay Host assigned to the Student by CHI (including but not limited to any losses or damages caused by the Student, the Student's long distance telephone expenses and medical expenses);
 - iv. the Agent hereby waives, releases and absolves and agrees to indemnify and save harmless CHI and its officers, Directors, employees, agents and independent service providers (including but not limited to the homestay Hosts and transportation service providers selected for the Student) from any and all liability for all the Student's losses and damages (including, but not limited to the loss or theft of the Student's money and the damage, loss or theft of the Student's personal belongings), personal injuries, or death, however caused; and
 - v. the Agent agrees that the Student must obtain any and all medical and travel insurance (including for sickness, personal injury, liability and personal belongings).
2. The Agent acknowledges their role in screening and preparing students for their experience in Canada. To that end, the Agent has read and agrees with the CHI Homestay Guide for International Students; and the Agent agrees to emphasize the importance of safety for their students.
3. The understanding and support of the Agent helps to ensure a satisfactory homestay experience, for everyone involved. In the event of a breach of this AA by the Agent, CHI and CHN reserve the right, in their absolute discretion, to notify the Agent of the breach (by fax or email or telephone) and provide the Agent with twenty-four (24) hours to remedy the breach, such remedy to be subject to the agreement of CHI.
4. The consequences of a breach of this Agreement by the Agent (including but not limited to the consequences described in paragraph 3) are without recourse to CHI and CHN, its officers and directors, employees, agents and independent service providers (including but not limited to any homestay Host and transportation service provider). The Agent further agrees to reimburse CHI on demand, its fees and expense related to any such breach. If any litigation arises relating to the Agreement between CHI, the Agent, the Student or their family, the Agent agrees that litigation must be conducted in the province of Canada where the dispute arose, pursuant to the laws of that province.
